Except as may be set forth herein, the Reporting Person has no current intention, plan or proposal with respect to items (a) through (j) of Item 4 of Schedule 13D.

Item 5. Interest in Securities of the Issuer

(a) Based on the disclosure in this statement and the foregoing, the aggregate number and percentage of Ordinary Shares of the Issuer owned by the Reporting Person is 8,752,600, constituting 41.78% of Ordinary Shares issued and outstanding as of the date hereof.

(b) The Reporting Person has sole voting and dispositive power over 8,752,600 Ordinary Shares.

(c) The Reporting Person entered into a Private Subscription Agreement with the Company on June 17, 2026, for the purchase of 1,500,000 Class A Ordinary Shares at a purchase price of US\$1.04 per share, for an aggregate subscription amount of US\$1,560,000. The purchase price was determined with reference to the market price of the Company's Class A Ordinary Shares as of June 17, 2026. The Reporting Person was also awarded 415,000 Class A Ordinary Shares as supplemental equity compensation on May 15, 2026, for his continued service to the Company during the 2026 financial year.
